Other Program Highlights:

- Learning Events: MOUSE offered 91 on-site orientations and tech trainings during this school year, with many new workshops covering specialist content in garage robotics, serious games and GreenTECH. Additionally, MOUSE held two live Team Training event with a total of 136 students attending from 20 schools. Our annual Coordinator-Con event for MOUSE educators was hosted at Google in the fall and MOUSE offered half-day trainings for our educators in Chicago in February.

- MOUSE Squad UnPlugged Events: MOUSE provided 14 UnPlugged opportunities for students and educators to strengthen the New York City learning network. These included Maker Faire, two PlayTech Saturday events, two level one Garage Robotics events and one level two offering, two BrainPOP game jams, one Scratch Jam at the Island School, two MakerBot PD opportunities for coordinators as well as a 3D Design & Fabrication workshop for teachers and students, the 6th Annual Emoti-Con! and a special opportunity for students to do 3D printing in conjunction with the American Museum of Natural History.

- Monthly MicroProjects: MOUSE had more than 740 submissions for our monthly MicroProject Competitions that give our students the opportunity to get creative with free online tech tools and cover a wide range of topics, from remixing a photos to make an ad, to designing a logo for a MOUSE Squad. We were also pleased to see about 60 submissions for our "DIY Competition," including videos, slide shows,

screencasts, and other step by step instructions teaching skills possessed by MOUSE Squad members across the nation.

- School/District Partnerships: During FY14, MOUSE brought on 8 new single-site schools and 3 new district partnerships: 8 charter schools from the Richard Milburn Academy Schools in Texas, 8 schools in the Normandy School District in Missouri, and 7 schools in AUSL network in Chicago.

- GreenTECH: GreenTECH aims to give schools an opportunity to kickstart "greening" efforts for their technology, or for students and coordinators looking for fun ways to blend technology with environmental science. This year, MOUSE launched a beta version of the GreenTECH Specialist module, which includes 3 new Specialist Wins! and the GreenTECH badge, as well as the GreenTECH Lab, with which students can record the kilowatt energy usage of multiple activity states of electronic devices around their classrooms and the school and make recommendations to reduce the carbon footprint in their schools.

- MakerBot: MakerBot has continued to partner with MOUSE to extend its 3D Design and Fabrication program to more than 30 schools across New York City and through our MOUSE Corps Design and Technology program to extend the ways members rapid prototype aspects of new assistive and adaptive designs. In June, students from two MOUSE Squads exhibited amazing 3D-printed projects at Emoti-Con! Far Rockaway's P256Q-Gateway Academy squad presented a 3D-printed zipper attachment that could aid people with physical disabilities to close zippers. The MOUSE Squad from Halsey Junior High School presented the 3D-printed dinosaur models and dioramas they designed as part of their apprenticeship with the American Museum of Natural History in February.

- MOUSE and Mozilla Summer Webmaker Institute: 14 Educators from across the national MOUSE Network attended our first-ever MOUSE & Mozilla Webmaker Summer

Over the 2 day event, they built their expertise around the competencies with the Web Literacy Map, playtested 9 new MOUSE webmaking activities, created and shared their own Open Education Resources that integrate web literacy into subject area learning and plan to implement a year of Webmaking at their schools in the fall.

- GadgITERATION: MOUSE joined forces with Brooklyn College Arts Lab (BCAL) and Parsons/The New School's GadgITERATION program -- a curriculum that offers an art and design-centered approach to technology -- to design and lead 2 weeks of free technology, tinkering and design day camps for middle and high school students in Brooklyn. 6 MOUSE Corps Students and several BCAL MOUSE students spent a week learning to lead hands-on, entry-level design workshops that encourage a creative and artistic engagement with technology, before leading the two weeks worth of camps as peer mentors, leading the campers in design and circuitry lessons and collaboratively building noise makers.
